Dear Sir, Madam,

You have family members aged 18 or over who are entitled to medical care in their country of residence, paid for by the Netherlands. For this, you have to pay a healthcare contribution to the CAK. This letter explains how much you will pay and how we calculate the healthcare contribution.

How much do you have to pay?

The healthcare contribution for your family members for 2023 is €1,240.07. You can see how this amount has been calculated in the enclosure.

When do you pay?

You can pay the amount in a single payment or in instalments. If you want to pay in instalments, the table below shows how much you will have to pay per month. You will also receive a final annual statement after the end of 2023. Any amount that has not been paid by then must be paid to us within 6 weeks.



Calculation of healthcare contribution for 2023

You pay a fixed monthly healthcare contribution under the Zvw scheme for your co-insured family members aged 18 or over. We multiply this contribution by the country-of-residence factor. This ensures that the healthcare contribution is proportionate to the extent and cost of the healthcare package in your country of residence.
